
Sub: Outcome of the Board Meeting of the Company held on February 14, 2020



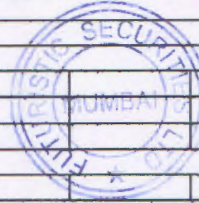


